DID YOU KNOW?

Care After School is licensed by the Ohio Department of Job and Family Services. You might have noticed your child's date of birth on the attendance sheets, when you pick your child up each day. This is a licensing requirement, and is necessary for us to post, in order to remain in compliance.



CAPACITY

The Ohio Department of Job and Family Services sets the capacity limits for Care After School. The number of children enrolled at each site is based on the amount of space available.

KEEPING OUR KIDS HEALTHY

In order to help keep our children and staff healthy throughout the year, Care After School follows strict cleaning guidelines. The Ohio Department of Job and Family Services requires a schedule for cleaning and sanitizing all toys, games, and surfaces. Hospital-grade disinfectants are used to ensure all supplies are cleaned thoroughly.

Many of these supplies are cleaned during the movie and technology time on Fridays. This gives CAS staff members a perfect opportunity to ensure all items are sanitized according to licensing standards.
